In addition under the ADA, a service animal is defined as a dog that has been individually trained to do work or perform tasks for an individual with a disability. The task(s) performed by the dog <u>must</u> be directly related to the <u>person's</u> disability. It should also be noted that a service dog will accompany an individual at all times and be leashed.


